## Note: This agreement is for the protection of the horse and the foster home, not to keep you from fostering one.

## APPLICATION PROCESSING

All information and references submitted on this application may be reviewed by our staff and in signing it you are agreeing to the terms within. Horses are placed on the basis of what is best for the horse at the time of need. In cases where there is more than one request for the same horse, the decision as to foster home will be voted on by our Board of Directors.

#### APPROVAL

Once this application is approved by the Forever Morgans Board of Directors and signed by a representative, it is a legally-binding contract and agreement regarding the foster's care of the foster horse(s).

It is agreed that said animal is in foster, only, and remains the property of Forever Morgans. It is further agreed that the horse may not be sold or transferred in any way into the custody of another person without prior approval, in writing, from Forever Morgans.

Foster understands that the horse in their care remains available for adoption and may be adopted at any time. Foster further agrees to assist in finding a suitable adoptive home for the horse in their care by providing evaluations as requested, monthly updates, and photos/videos of the horse to be used in promoting it for a forever home, and responding to potential adopters promptly and honestly. Updates, information, photos and videos submitted become the property of Forever Morgans and may be used and published in marketing and other material.

Foster understands that they are responsible for the ordinary day to day expenses of the fostered Morgan (feed, housing, farrier, shots, ordinary veterinary care). Forever Morgans is responsible for the horse's expenses prior to its arrival at the foster home, including purchase, quarantine (if applicable), transporting it to the foster home, and costs of extraordinary veterinary care, euthanasia and carcass disposal, if necessary.

Finally, the undersigned agrees that the horse is not to be bred without prior approval by Forever Morgans. Any foal born to a foster mare falls under the same conditions per this agreement as the dam.

In the event the undersigned fails to comply with the terms of this Application and Agreement, Forever Morgans reserves the right to commence legal proceedings to recover the horse, and the undersigned shall be liable for all costs including damages to Forever Morgans Rescue, Inc. is assumed at a minimum of \$5,000.00, inclusive of attorney's fees, in connection with such legal proceeding.

#### How Forever Morgans Fostering Works

- 1. Forever Morgans fosters are the backbone of our rescue. Horses that are rescued and do not go to their adoptive homes right away need a place to stay, to be cared for, helped to recuperate, taught that some humans can be trusted, and to be evaluated in preparation for adoption by their forever homes.
- 2. Foster homes agree to assist in promoting the foster horse in their care by providing evaluations as requested, taking photos (and video, if possible), and providing frequent updates to be used in promoting the horse for a forever home, and responding to potential adopters promptly and honestly.
- 3. The Board decides each horse's foster home based on the foster's skills and the horse's needs. Fosters are welcome to suggest which horses they think that they can best help, but do not get to pick which foster horse they are going to receive. Requirements such as "no mares due to stallion on premises" or "can or can't– provide driving evaluation" or "willing and able to provide special needs care for a special needs horse" will be carefully considered.
- 4. Forever Morgans does not do "trial adoptions," where a specific horse is fostered with the intention of being adopted by the foster. We do understand that bonding occurs, and it is not uncommon for a foster home to fall in love with a horse and then adopt it. If a foster home is considering adopting the horse but is not yet decided, they should continue to assist in promoting the horse in seeking a good forever home. If an approved adoptive home wishes to adopt the horse, the foster home must immediately decide whether or not to adopt as it would not be fair to the horse for it to lose a chance at a good forever home while a human tries to make up their mind. The Board will determine at that time whether the foster home or applicant is the best placement for that horse and approve the adoption accordingly.
- 5. If a foster home chooses to adopt the horse within 90 days of the horse's arrival, the foster will reimburse Forever Morgans the cost of transporting the horse to them in addition to the adoption fee. If a foster home chooses to adopt the horse more than 90 days after the horse's arrival, the foster will reimburse Forever Morgans half (50%) the cost of transporting the horse to them in addition to the adoption fee.
- 6. Fosters are responsible for the day-to-day costs of caring for the horse, including feed, shelter, farrier, ordinary veterinary care, worming, vaccinations, and teeth floating.
- 7. Forever Morgans is responsible for the horse's expenses prior to its arrival at the foster home, including purchase, quarantine (if applicable), transporting it to the foster home, and costs of extraordinary veterinary care (see procedures below), euthanasia and carcass disposal, if necessary.
- 8. In the event that a horse needs more than ordinary veterinary care, the foster must put the veterinarian in contact with the Forever Morgans Board PRIOR to any care. The Board, in consultation with the vet and the foster, will make decisions regarding the care of the horse and communicate those to the vet and foster. Forever Morgans will be billed and pay the vet directly. In an emergency medical situation, in the event the foster attempts to but is unable to contact the Forever Morgans Board, the foster should consult with the vet and follow his/her recommendation; the foster is authorized to have the horse euthanized if the vet deems it necessary.
